Overview

This course is being offered free as part of an initiative by the WA Mental Health Commission. This training will take place during regular working hours and we recommend that individuals have full support of their workplaces before applying.

This is an intensive and fast paced course which provides training in Peer to Peer - discipline specific supervision (as distinct from line management or clinical supervision), by and for, the mental health consumer/Peer Workforce in Western Australia.

The training will include a mixture of:

- Weekly in-person training sessions in the Perth Metropolitan area
- Reflective practice homework and mandatory reading activities to be completed outside of class time (approx. 2 hours per week)
- Assessments: to be completed both within and outside of class time

ELIGIBILITY CRITERIA

To be eligible to be considered for this course, you must be able to demonstrate that you meet all the criteria below.

1. A demonstrated experience working from a [Consumer Perspective](#), in a lived experience role or roles within WA (minimum 1 year's recent experience).
2. Experience supporting or providing discipline- specific supervision to Peer Workers or are in the process of building their capacity to do so in the future.

3. Willingness to lean into vulnerability and unpack your thinking and frameworks in class through role plays and feedback discussions (exploring biases, assumptions, privilege and power etc.)
4. Able to apply effective reflective practice techniques in their daily lives.
5. Comfortable participating in classroom discussions, role plays and self-reflection.
6. Demonstrated understanding of social justice principles and how these influence various groups and individuals.
7. Clear understanding of personal and professional boundaries, and how to implement them.

- The Peer Supervision Training will be run weekly on Monday, 12:30pm-4.30pm. Course will commence 10th March 2025.
- You will be expected to complete ongoing learning outside of course time. Three practical assessments will occur in class, but some written responses will be required to be completed in your own time. Reasonable adaptations are available, upon request.

This includes a combination of written assessments, reflections, and role play scenarios. Further information on assessments will be provided in Session 1. You must be deemed competent in all assessments to pass this course.
